GOOD AFTERNOON TO THE PEOPLE OF THE VIRGIN ISLANDS. AS I MAKE MY TRANSITION FROM THE POSITION OF LEGAL COUNSEL TO THE GOVERNOR TO THAT OF A JUDGE OF THE SUPERIOR COURT, I HAVE BEEN MADE AWARE OF CERTAIN PUBLIC STATEMENTS WHICH ACCUSE ME OF BEING DISHONEST. SPECEICALLY, IN MY TESTIMONY BEFORE THE COMMITTEE OF RULES AND JUDICIARY OF THE 28TH LEGISLATURE, AT A HEARING HELD ON NOVEMBER 20, 2009, IN ST. CROIX, VIRGIN ISLANDS, I WAS ASKED WHETHER I ATTENDED A MEETING OF THE VIRGIN ISLANDS PUBLIC FINANCE AUTHORITY WHICH WAS HELD ON OCTOBER 6, 2009 IN ST. THOMAS, VIRGIN ISLANDS. I RESPONDED TRUTHFULLY, UNDER OATH, THAT I DID NOT ATTEND THAT MEETING. TO PUT THIS MATTER TO REST FOR ONCE AND FOR ALL, I AM STATING TO ALL OF PEOPLE OF THE VIRGIN ISLANDS, UNEQUIVOCALLY AND WITHOUT ANY RESERVATION WHATSOEVER, THAT I STAND BY MY SWORN TESTIMONY. **I DID NOT ATTEND THE MEETING OF THE VIRGIN ISLANDS PUBLIC FINANCE AUTHORITY HELD ON OCTOBER 6, 2009 IN ST. THOMAS, VIRGIN ISLANDS.**

I ALSO NOTE THAT I WAS NEITHER INVITED NOR SUBPOENAED TO EITHER ATTEND THE LEGISLATIVE HEARING HELD ON JANUARY 19, 2010 OR PRODUCE DOCUMENTS FOR THAT HEARING. THEREFORE, I WAS NOT PART OF THE PROCESS OF REVIEW FOR THE DOCUMENTS PRESENTED TO THE LEGISLATURE IN CONNECTION WITH THAT HEARING. AGAIN, TO THE EXTENT THAT ANY DOCUMENT REFLECTS THAT I ATTENDED THE MEETING OF THE VIRGIN ISLANDS

PUBLIC FINANCE AUTHORITY HELD ON OCTOBER 6, 2009, IN ST. THOMAS, VIRGIN ISLANDS, THAT INFORMATION IS INCORRECT.

I THANK THE PEOPLE OF THE VIRGIN ISLANDS WHO HAVE SUPPORTED ME THROUGHOUT THIS PROCESS, AND I LOOK FORWARD TO ASSUMING THE POSITION OF JUDGE OF THE SUPERIOR COURT AND SERVING ALL OF THE PEOPLE OF THE VIRGIN ISLANDS IN THAT CAPACITY WITH FAIRNESS, HONESTY, AND FIDELITY.
