Recall Petition Circulation Instructions

Recall Petitions for Election Board members *Ana L. "Anita" Davila, Carmen Golden, Dodson K. James, Lisa Harris-Moorhead, Esq., Rupert W. Ross, Jr., and Raymond J. Williams* were submitted to the Election office the afternoon of Thursday, January 12, 2012. Effective January 12, 2012, recall petition circulation began. **We have 60 days, from our January 12th submittal date, to collect signatures.**

If you receive a hard copy of the Recall Petitions, you will be required to complete a distribution form with your contact information. However, if you download the petitions from the Internet, you must submit your contact information by email to hplace2@hotmail.com or by giving your name, address, and telephone number to **Evelyn Bascombe at 340-227-3535 or Colleen at 340-277-4386**. Your privacy is of utmost importance and will be protected. We do need a way to contact you to collect petitions and encourage you in the recall effort by informing you where drives will be held, answering questions you may have, and getting you additional petition forms, etc.

You may copy additional signature pages only. However, any additional signature pages **MUST** be printed on legal sized paper, for consistency. You can get this done at Office Max or any other office supply/printing company. It is important to ask everyone if they are a registered voter before they sign the petition. **ONLY THOSE SIGNATURES FROM REGISTERED VOTERS WHO VOTED IN THE LAST TWO GENERAL ELECTIONS COUNT!!!!**

Once you've collected all the signatures on the number of Petitions you have, take the last sheet (**Affidavit of Circulation**) and complete it. If you obtain additional signature pages, only one Affidavit of Circulation is required. **YOU MUST GET IT NOTARIZED! BE SURE TO SIGN IT IN FRONT OF THE NOTARY PUBLIC.** The charge for notarizing a document is only \$5. If you encounter individuals who are interested in circulating a petition, please inform them to contact Evelyn Bascombe or Colleen Clarke, so we can make sure they get copies of the petition, along with circulation instructions.

If you want to hold a petition signing drive somewhere, please let us know where so we can make an announcement via a press release, news, radio talk shows, newspaper, word of mouth, etc. If you have questions, **call Evelyn Bascombe at 340-227-3535 or Colleen at 340-277-4386.**
